1. Assumption of Risk. In consideration of my participation in YTM Bubble Ball Soccer and games; I hereby release, discharge, do not hold liable, and hold harmless Yukon Transportation Museum Society and its officers, directors, employees, members, volunteers, subsidiaries, agents, successors, and assigns from any and all liability that may arise, directly or indirectly, now or in the future, by reason of any injury, damage, loss or expense incurred in connection with my participation in YTM Bubble Ball Soccer & games. Including that caused solely or in part by the fault (including but not limited to negligence, gross negligence, and/or recklessness) of the above named parties.

2. Consumption of Alcohol/Drugs. I understand that the consumption of alcohol/drugs is NOT permitted while playing Bubble Ball Soccer & games. I acknowledge the potential risks and dangers associated with the consumption of alcohol/drugs and take full responsibility for any liability associated with my intoxication, before or during play, with YTM Bubble Ball Soccer and Games.

3. Medical Declarations. I represent that I do not have, and/or YTM is not aware of, any medical condition(s) including pregnancy that may impact my participation in YTM Bubble Ball Soccer and Games.

4. Publicity Release. In connection with my participation in the production of any print, audio, or filmed program material produced by YTM Bubble Ball. I hereby grant, assign, and convey to YTM all rights, titles, and interest I may have in and to the specified program material in and to any reproduction made there from. I also irrevocably authorize YTM free of charge and without limitation to broadcast, distribute, and/or exhibit the specified program material and any reproduction made there from or any portion there of. This also specifically includes permission for me to appear in photographs or videotapes of the events.

IN SIGNING THIS AGREEMENT, I ACKNOWLEDGE AND REPRESENT THAT I have read and understand this Release and Waiver of Liability Agreement. This agreement will be binding upon my heirs, next of kin, executors, administrators, and successors. *Parent/Guardian Waiver for Minors (if participant is under 18) the undersigned parent, natural guardian, or legal guardian does hereby represent that she/he is in fact acting in such a capacity and agrees to defend, save, hold harmless, and indemnify each and all parties referred to above from all liability, loss, cost, claim, or damage whatsoever which may be imposed upon said parties because of any defect or lack of such capacity to so act and release said parties on behalf of both the minor, parent or legal guardian. It is understood that participants must be at least four feet tall and able to carry 25 pounds. Participants over 6'1 or 250lbs may not be able to play – a pre-fitting is required. If I have any health concerns and/or if I am over 60 years old I will consult my doctor prior to participating.*
